# Information on the processing of personal data

**Subject:** Information concerning the ARIES (Augmented and immersive Reality for Improved Education in Schools in Europe) project and regulation of the use for research purposes of data collected through questionnaires

The ARIES project aims at the development and dissemination of feasible and low-threshold, and low-cost facilitation concepts for secondary school teachers and learning modules for secondary school students on Augmented and Immersive Reality (A&IR) learning technologies. School teachers and students will be equipped with the necessary skills and competences to facilitate and apply innovative learning approaches and open-source A&IR learning technology solutions in existing courses, curricula and study projects.

### 2) Purposes for which data processing is necessary and its legal basis

Personal data (in particular job title, work area), will be processed for scientific research purposes by BLINC.

# 3) Personal data retention period

BLINC will retain personal data for research purposes for a period of time no longer than the achievement of the purposes for which they are collected or subsequently processed and in any case no longer than 5 years.

## 4) Method and logic of data processing

The data will be processed manually and/or by means of computerised and telematic tools, with logics of organisation and processing of the data correlated to the purposes indicated above and, in any case, in such a way as to guarantee the security and confidentiality of the data.

## 5) Recipients

The data will be processed by BLINC employees who have been previously authorised to process personal data and have received adequate operating instructions in this regard. The data may circulate within the ARIES consortium in anonymous format.

## 6) Categories of third parties to whom the data may be communicated as Data Controllers or who may become aware of them as Data Processors

Data and search results may be transferred to third parties or published in anonymous and aggregate form.

The above-mentioned third parties are essentially included in the following categories: a) any BLINC consultants or scientific partners; b) Landesbeauftragte für Datenschutz in Niedersachsen (State Commissioner for Data Protection in Lower Saxony). In any case, data will not be transferred to countries outside the European Union.

### 7) Right of access to personal data and other rights

Considering that the data is collected and processed strictly in anonymous form, it will not be possible for the data subject to request access, rectification and/or deletion of his/her data.
